

Gingerbread NYC: The Great Borough Bake-Off 2023

RULES AND PROCEDURES



The Museum of the City of New York invites professional and amateur bakers from across the city to apply for entry to ***Gingerbread NYC: The Great Borough Bake-Off 2023*** – our 2nd annual celebration of communities and neighborhoods in each of the five boroughs as represented in gingerbread. The selected displays will be on public view in a gallery at the Museum from **Friday, November 10, 2023, through Monday, January 15, 2024.**

Stipend:

Each bakery/individual baker selected to participate will receive a stipend in the amount of \$500.00 toward materials and supplies. Stipends will be distributed after the participating bakers have been selected and have submitted their complete entry packet (photo release, display agreement, W9, etc.)

How to Submit:

Please complete the [Entry Form](#) and submit up to three (3) photographs that are representative of your baking. **The deadline to submit is Wednesday, September 20, 2023 at 11:59 PM EST.**

Key dates:

Wed., Sep. 20 – Deadline to enter

Fri., Sep. 22 – Bakers will be informed of selection

Mon., Oct. 2 – Deadline for bakers to submit designs with accurate dimension for approval

Fri., Oct. 6 – Bakers will receive design approval/feedback

Mon., Oct. 30 thru Wed., Nov. 1 – Bakers install gingerbread displays

Thu., Nov. 2 thru Mon., Nov. 6 – Final judging

Wed, Nov. 8 – Press preview

Fri., Nov. 10 – Open to the public

Mon., Jan. 15, 2024 – Last day on view to the public

Theme

This year's theme for **Gingerbread NYC** is "Iconic New York"—distinctive buildings, places, or things that represent your neighborhood, community, or borough.

Prizes

Prizes will be awarded in a variety of categories.

Size Limitations

Each baker will be provided with a display area measuring 40"W x 30"D x 36"H. The gingerbread display should not extend beyond this area. Each display should be on a base. Plywood ($\frac{1}{2}$ " or $\frac{3}{4}$ ") as a base for your display is recommended. Gingerbread displays combined with a base must not be larger than 36" high. Use of pegs/risers/feet on the bottom of the base is preferred but not required. If you wish to install pegs/risers/feet on the underside of your base, they are considered part of the base and must not cause the entry's overall height to exceed 36". Weight is not to exceed 50 lbs.

Materials and Construction

Everything above the base of your entry must be composed completely of edible materials. Competitors are permitted to use up to 40% mechanically produced components in their entry. Examples include: machine designed, 3D printed, and laser cut components. 60% of each entry must be handcrafted. The main structure of your entry must be constructed of at least 75% gingerbread, some of which should be exposed.

Edible materials are not limited to candies and icings. Use of gum paste, fondant, pastillage, chocolate, modeling chocolate, royal icing, isomalt, cast sugar, gelatin and pressed sugar is encouraged. Use of "Disco Dust", "Rainbow Dust" or "Hologram Powder" is permitted.

No artificial display materials, such as Styrofoam, interior lighting or other electronic components are to be used in the construction or decoration of the creation. Candies must be unwrapped and free of any non-edible materials, such as lollipop sticks. Non-edible materials such as paint and/or ribbon are approved and encouraged to decorate the outer edge of your plywood base only. Decorations must not cause the entry to exceed the required size limitations.

Terms and Conditions

1. I acknowledge that my entry will remain on display during the times specified by the Museum of the City of New York (MCNY). (Expected public display dates are November 10, 2023 through January 15, 2024.)
2. Unless otherwise agreed upon, I must pick up my entry between the hours of 10 am and 6 pm on Tue., Jan. 16, or Wed., Jan. 17, 2024. Entries remaining will be discarded beginning at 7pm on Wednesday, January 17, 2024.
3. By voluntarily participating in Gingerbread NYC, I've consented to receive email communication from MCNY, the event itself, and future Gingerbread NYC planning and media requests as they arise.
4. I agree to make myself and/or my bakery representative(s) available for interviews, photographs, filmed or taped recordings, etc. by MCNY or press/news outlets coordinated by MCNY with as much advance notice as possible and not to be unreasonably denied.
5. Bakers may be asked to make periodic repairs or adjustments over the period of public display dates. Such repairs and/or adjustments are to be covered by the original

stipend.

6. I hereby grant permission to MCNY to print or otherwise duplicate the picture or likeness of my creation and/or myself with my creation for either internal or external release; this includes print, video and online publications, plus local and network television. I understand that the image of my creation becomes the property of MCNY. I understand that at no time does MCNY guarantee the safety or security of my creation and MCNY cannot be held responsible for any damages incurred to my creation. Participation in the competition includes filmed interviews, photographs and audio recordings of the process. By participating, each bakery agrees to be bound by all rules and procedures herein, which may be amended from time to time. MCNY reserves the right to refuse entries that are deemed inappropriate for display at the Museum, to disqualify any bakery who fails to follow the rules and procedures contained herein, and/or to disqualify any bakery who falsifies any entry form information.
7. I agree to HOLD HARMLESS, RELEASE, DEFEND, AND INDEMNIFY MCNY, each of its current or former predecessors, successors, each of its affiliated organizations and companies, its insurance companies, respective agents, employees, representatives, assignees, officers, directors, members, partners, medical providers and shareholders (each a "RELEASED PARTY") for ANY AND ALL LIABILITY and/or claims arising from injury to persons or damage to property arising from the incident, any RELEASED PARTY'S alleged or actual NEGLIGENCE OR GROSS NEGLIGENCE, BREACH OF any express or implied WARRANTY, breach of contract, or breach of any statutory or other duty of care, or mistakes or errors in judgment of any kind. By signing this release, I agree that I am releasing any right to make a claim or file a lawsuit against MCNY. THE RELEASOR AGREES TO DEFEND AND INDEMNIFY each RELEASED PARTY for any and all claims and/or those of a third party arising from the incident.
